**MUNICIPAL SPATIAL DEVELOPMENT FRAMEWORK (MSDF)**

Notice is hereby given in terms of Section 28(3) and 29 of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000), Section 20 of the Spatial Planning and Land Use Management Act, 2013 (Act 16 of 2013), and Section 11 of the Western Cape Land Use Planning Act, 2014 (Act 13 of 2014) that the Overberg District Municipality intends to adopt its approved Municipal Spatial Development Framework (MSDF).

An MSDF is a long-term forward-planning document that spatially indicates the long-term growth and development path of a municipality. It coordinates the spatial implications of all strategic sector plans (transport, environmental, resources, economic, community services, etc) of a municipality. An MSDF is also one of the core components of a municipal IDP and gives physical effect to the vision, goals and objectives of the municipal IDP. Once completed, the MSDF will be approved in terms of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000) and will serve as a guide to decision making in development and land use planning.

In terms of Section 11(b) of the Land Use Planning Act, 2014 (Act 13 of 2014) (LUPA), the Municipality has opted not to establish an Intergovernmental Steering Committee. Therefore, a Project Committee, responsible for the compilation or amendment of the MSDF, will be established. This Committee will adhere to the procedural requirements outlined in Section 13 of LUPA and Section 7 of the Standard by-Law, the core emphasis of which is the allowance of 60 days for all stakeholders to comment on the draft document.

Comments, inputs or representations regarding the MSDF must reach the Office of the Municipal Manager on or before 15 June 2017.
