

NOTICE TO ALL SUPPLIERS/SERVICE PROVIDERS TO THE CAPE AGULHAS MUNICIPALITY



PREFERENTIAL PROCUREMENT REGULATIONS (B-BBEE) IMPLEMENTATION

Please note that in terms of the National Treasury Preferential Procurement Regulations, 2011 the Cape Agulhas Municipality, with effect from **7 December 2011**, may only award preferential points to suppliers in respect of their B-BBEE contribution status. These Regulations together with other relevant legislation can be viewed on www.treasury.gov.za.

All Service Providers **MUST** submit a B-BBEE Certificates as issued by:

- The verification agencies accredited by the South African National Accreditation System (SANAS) or
- Registered Auditors approved by the Independent Regulatory Board of Auditors (IRBA) in accordance with the approval granted by the Department of Trade and Industry (DTI)

It must be noted that no service provider will be contracted that fail to submit a valid original Tax Clearance Certificate from the South African Revenue Services (SARS) certifying that its taxes are in order or that suitable arrangements have been made with SARS.

All **prospective** Service Providers are invited to register as a supplier on the Cape Agulhas Municipal Supplier Database. Enquiries regarding the registration process may be referred to Mr I January at 028 425 5500 or IsakJ@capeagulhas.com.

- Die verifikasie-agentskappe geakkrediteer deur die Suid-Afrikaanse Nasionale Akkreditasie Stelsel (SANAS) of
- Geregistreerde Ouditeure goedgekeur deur die Onafhanklike Regulerende Raad van Ouditeure (IRBA) in ooreenstemming met die goedkeuring verleen deur die Departement van Handel en Nywerheid (DTI)

Daar moet kennis geneem word dat geen diensverskaffer gekontrakteer sal word wat versuim om 'n geldige oorspronklike belastingklaringsertifikaat van die Suid-Afrikaanse Inkomstediens (SAID) wat sertifiseer dat sy belasting in orde is of dat geskikte reëlings getref is by die SAID in te dien.
